

## COVID-19 Updates from MIOSHA, MDHHS and more

To Our Valued Clients:

With a rise in COVID-19 cases over the last several weeks, we have seen several changes and updates from the State of Michigan. We are including a lot of information in this email, and hope you will find some useful tools.

- MIOSHA has put a stronger focus on remote work. "Employers must prohibit in-person work when an employee's duties can feasibly be completed away from the office. Remote work for office employees is a crucial mitigation strategy to contain the spread of COVID-19," said MIOSHA Director Bart Pickelman. "Some workplaces, including offices, seem to be lax on requiring certain protocols. As our numbers rise, all workplaces in Michigan must promote and continue remote work to the absolute maximum. Congregating in any setting leads to potential spread and remote work helps mitigate some degree of congregation."
  - There is a requirement to include your remote work policy in your Business Preparedness Plan, and MIOSHA provided a sample that Low or Medium-Risk Industries can use: MIOSHA Business Preparedness Plan
